**TERMINATION OF SHORT FORM INTELLECTUAL PROPERTY SECURITY  
AGREEMENT  
AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This TERMINATION OF SHORT FORM INTELLECTUAL PROPERTY SECURITY AGREEMENT AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release"), dated as of October 10, 2014, is made by and among Bank of Montreal, as administrative agent ("Administrative Agent"), in favor of Cision US Inc. (the "Grantor") as follows:

**WITNESSETH**

WHEREAS, pursuant to the Short Form Intellectual Property Security Agreement, dated as of June 10, 2014 (the "Security Agreement"), and recorded with the U.S. Patent and Trademark Office on June 10, 2014 at Reel/Frame No. 5299/0172, the Grantor granted the Administrative Agent a Lien on and continuing security interest in, all of its right, title and interest in, to and under the "Collateral" (as defined therein) pledged by the Grantor described therein, including, without limitation, the United States trademarks set forth on Schedule A attached hereto (collectively, the "Trademarks") and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks;

WHEREAS, the Grantor has paid all of its outstanding indebtedness to the Administrative Agent; and

WHEREAS, the Grantor has requested that the Administrative Agent release its Lien on and continuing security interest in, all right, title and interest of the Administrative Agent in and to the Collateral.

NOW, THEREFORE, the Administrative Agent, without recourse, representation or warranty and at the Grantor's sole cost and expense, hereby terminates, cancels and releases its Lien on and continuing security interest in the Collateral, including the Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, and any and right, title and interest of the Administrative Agent in the Collateral shall hereby terminate, cease and become void.

The Administrative Agent agrees to provide the Grantor with any information and additional authorization and documentation necessary to effect the release of the Administrative Agent's security interest in the Collateral (without recourse, representation or warranty and at the Grantor's sole cost and expense).
