TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of October 8, 2014 by MARANON CAPITAL, L.P., as Agent for Lenders ("**Agent**").

WITNESSETH:

WHEREAS, Agent and Kettle Cuisine, LLC, a Delaware limited liability company ("**Grantor**"), were parties to that certain Trademark Security Agreement dated as of July 29, 2011 (the "**Assignment**"), pursuant to which Grantor granted a security interest to Agent in certain trademarks (the "**Trademarks**") and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the United States Patent and Trademark Office on August 1, 2011, at Reel 004595, Frame 0280; and

WHEREAS, Grantor has requested that Agent release its security interest in and lien on the Trademarks and Trademark Collateral and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases and discharges fully its security interest in and lien on all of Grantor's right, title and interest in and to the following (collectively, the "**Trademark Collateral**"):

(i) all of its Trademarks, including those referred to on Schedule 1 attached hereto;

(ii) all reissues and extensions of the foregoing;

(iii) all goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(iv) all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any or (b) injury to the goodwill associated with any Trademark.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademark Collateral.


