## TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment") is made effective as of 12:01 AM October 10, 2014, by and between Alere Health Improvement Company, a Delaware corporation ("AHIC"), and Alere Health, LLC, a Delaware limited liability company ("Alere Health").

**WHEREAS**, AHIC has adopted, used and is currently using the marks identified in the attached Exhibit A and owns the corresponding registrations of the marks also identified in Exhibit A (collectively, the marks and corresponding registrations being the "AHIC Marks");

**WHEREAS**, AHIC has, as of the date hereof, approved the distribution of the AHIC Marks to Alere Health, its sole shareholder;

**WHEREAS**, Alere Health has adopted, used and is currently using the mark identified in the attached Exhibit B, and owns the corresponding application for registration of the mark also identified in Exhibit B (collectively, the mark and corresponding application for registration being the "Alere Health Mark");

**WHEREAS**, AHIC wishes to assign to Alere Health (a) all of its right, title, and interest in and to the AHIC Marks and (b) all of its right, title, and interest (if any) in and to the Alere Health Mark;


**NOW THEREFORE**, in consideration of the foregoing, and for good and valuable consideration, the receipt of which is hereby acknowledged:

1. AHIC hereby assigns to Alere Health all of its right, title and interest throughout the world in and to the AHIC Marks, including any common law rights therein, the good will of the ongoing and existing business and the portions thereof symbolized by, associated with or otherwise pertaining to the AHIC Marks.
2. AHIC hereby acknowledges that, as between AHIC and Alere Health, Alere Health owns all of the right, title and interest throughout the world in and to the Alere Health Mark, including any common law rights therein, the good will of the ongoing and existing business and the portions thereof symbolized by, associated with or otherwise pertaining to the Alere Health Mark.
3. For the avoidance of doubt, AHIC hereby assigns to Alere Health all of its right, title and interest (if any) throughout the world in and to the Alere Health Mark, including any common law rights therein, the good will of the ongoing and existing business and the portions thereof symbolized by, associated with or otherwise pertaining to the Alere Health Mark.
4. The assignments herein include any income, royalties, damages, or payments due in connection with the AHIC Marks and the Alere Health Mark on or after the effective date hereof, including, without limitation, all claims for damages or payments by reason of infringement or unauthorized use of the AHIC Marks and the Alere Health Mark (whether past or future), along with the right to sue for past and future infringements and collect damages for same.
5. AHIC will execute and deliver to Alere Health such further agreements and other documents, including without limitation trademark assignment documents, and take such other actions as may be necessary to more fully perfect, evidence and record the transfer of rights in this Assignment and the rights of Alere Health in the assets assigned herein.


