## NUNC PRO TUNC TERMINATION OF SECURITY INTEREST

This TERMINATION OF SECURITY INTEREST, dated as of October 6, 2014, is made by VENTURE LENDING & LEASING VI, INC. (the "Secured Party") in favor of EDO INTERACTIVE, INC. (the "Grantor").

WHEREAS, pursuant to a Loan and Security Agreement and an Intellectual Property, Security Agreement, both dated as of December 30, 2011, between the Secured Party and Grantor, Grantor granted a continuing security interest in and general lien upon certain trademarks, trademark applications, and patents (the "Pledged Intellectual Property Collateral");

WHEREAS, notice of the security interest granted to the Secured Party was recorded at the United States Patent and Trademark Office at reel and frame numbers: 4695/0457 and 027507/0264; and

WHEREAS, the Secured Party has agreed to terminate and release its security interest in the Pledged Intellectual Property Collateral and all of Grantor's other trademarks, trademark applications, patents, patent applications, and copyrights, including without limitation, those identified on Schedule A, attached hereto.

NOW THEREFORE, for valuable consideration, the receipt and sufficiency of which is acknowledged, the Secured Party hereby terminates and releases, without representation, recourse or warranty whatsoever, all mortgages, liens, and security interests granted to the Secured Party in the following:

1. the Pledged Intellectual Property Collateral and all of the Grantor's other trademarks, trademark applications, patents, patent applications, copyrights, including registered and unregistered copyrights and copyright applications, including, without limitation, those identified on Schedule A, attached hereto (collectively, the "Released Intellectual Property Collateral");
2. all goodwill of the business connected with the use of, and symbolized by, each of the trademarks and trademark applications that are included within the Released Intellectual Property Collateral (collectively, the "Goodwill"); and
3. all products and proceeds of the Released Intellectual Property Collateral and Goodwill, including without limitation, any claim by the Grantor against third parties for past, present, or future (i) infringement or dilution of any of the trademarks or trademark applications encompassed by the Released Intellectual Property Collateral; (ii) infringement of any of the copyrights, including without limitation registered and unregistered copyrights and copyright applications, encompassed by the Released Intellectual Property Collateral; and (iii) injury to the Goodwill associated with any copyrights, registrations, and applications and trademarks and trademark applications encompassed by the Released Intellectual Property Collateral.
