TRADEMARK ASSIGNMENT

This Trademark Assignment is entered into by and between Continental Heating and Air Conditioning, Inc. ("CHAC"), a California corporation with a business address at 3030 Meyers Street, Riverside, California, United States, and Venvest Ballard, Inc., a California corporation with a business address at 3030 Meyers Street, Riverside, California, United States ("VBI"), effective as of May 30, 2014.

WHEREAS, CHAC intended to use in commerce the trademark RIGHTIME and various slogans associated therewith in connection with business, franchise and home services (the "Marks"), and filed the various applications with the U.S. Patent and Trademark Office ("USPTO") set forth in Annex A and Canadian Intellectual Property Office ("CIPO") set forth in Annex B indicating such intention, but has not yet filed any allegations of use under § 1(c) or (d) of the Trademark Act or corresponding Canadian provisions;

WHEREAS, pursuant to an asset purchase agreement, CHAC sold, transferred and assigned the Marks as part of the sale of that portion of CHAC's business to which the Marks pertain as required by 15 U.S.C. § 1060 and others;

WHEREAS, VBI purchased that portion of CHAC's business to which the Marks pertain, acquired said Marks and the pending applications therefor, and now desires to confirm the Assignment of the Marks for purposes of filing the same with the USPTO and CIPO as well as any applicable foreign trademark offices;

NOW, THEREFORE, for good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, CHAC does hereby assign to VBI, all right, title and interest in and to the Marks, together with the goodwill of the business symbolized thereby, the U.S. Applications therefore, the Canadian Application therefore, and all rights to proceeds of the foregoing, including, without limitation, any claim by CHAC against third parties for past, present, or future infringement of the Marks.


