TRADEMARK SECURITY AGREEMENT (JUNIOR)

This Trademark Security Agreement (this "*Agreement*"), is entered into as of January 4, 2011 by PROXIM WIRELESS CORPORATION, a Delaware corporation (the "*Grantor*"), in favor of PROXAGENT, INC. as the collateral agent (the "*Collateral Agent*"), for the benefit of the Junior Lenders (as such term is defined in the Security Agreement referred to below) (in such capacity, and together with its successors in such capacity, the "*Secured Party*").

W I T N E S S E T H:

WHEREAS, the Grantor is a party to a Junior Security and Pledge Agreement dated as of January 4, 2011 (as amended from time to time, the "*Security Agreement*") in favor of the Secured Party pursuant to which the Grantor is required to execute and deliver this Agreement;

NOW, THEREFORE, in consideration of the foregoing premise, the Grantor hereby agrees with the Secured Party as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

SECTION 2. Grant of Security Interest in Trademark Collateral. The Grantor hereby pledges and grants to the Secured Party for the benefit of the Junior Lenders a lien on and a security interest in and to all of its right, title and interest in, to and under all:

(a) Marks for which registrations or applications for registration are listed on Schedule I attached hereto; and

(b) Proceeds of any and all of the foregoing.


SECTION 3. Security Agreement. The security interest granted pursuant to this Agreement is granted in conjunction with the security interest granted to the Secured Party pursuant to the Security Agreement, and the Grantor hereby acknowledges and affirms that the rights and remedies of the Secured Party with respect to the security interest in the Marks made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control.
