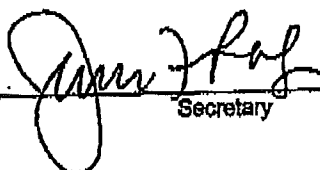

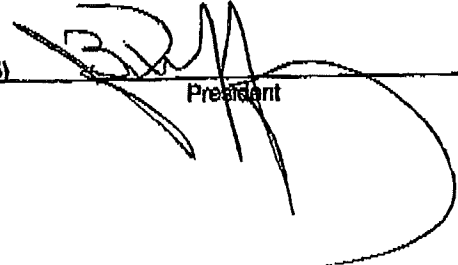

"The name of the corporation (hereinafter "Corporation") is:

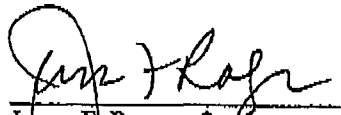

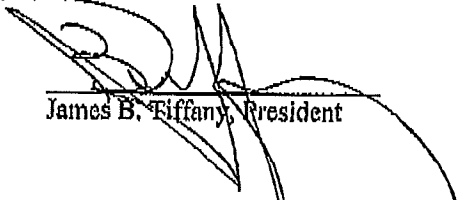
