RELEASE OF SECURITY INTEREST

WHEREAS, Stoneridge Control Devices, Inc., a Massachusetts corporation located at 300 Dan Road, Canton, Massachusetts, 02021 (the "Company") entered into a Senior Secured Notes Pledge and Security Agreement, dated October 4, 2010 (the "Security Agreement"), among the Company, Stoneridge, Inc., an Ohio corporation ("Stoneridge"), Stoneridge Electronics, Inc., a Texas corporation ("Electronics") and The Bank of New York Mellon Trust Company, N.A., a national banking association, with its designated corporate trust office located at 2 North LaSalle St., Suite 1020, Chicago, Illinois, 60602, as collateral agent (the "Agent") for the secured parties set forth therein (the "Secured Parties");

WHEREAS, pursuant to the Security Agreement, the Company entered into a Grant of Security Interest in Trademark Rights dated October 4, 2010 (the "Security Interest"), wherein the Company pledged, assigned, and granted to the Agent for the benefit of the Agent and the Secured Parties in its Intellectual Property, including the trademarks set forth on Schedule A (the "Trademarks");

WHEREAS, on October 15, 2014, the Security Agreement terminated pursuant to Section 8.14 of the Security Agreement upon the Company's satisfaction of all of the conditions precedent to the satisfaction and discharge of that certain Senior Secured Notes Indenture, dated as of October 4, 2010, among the Company, Stoneridge, Electronics and Agent; and

WHEREAS, the Agent desires to release the Security Interest with respect to the Trademarks, and in executing the release, the Agent shall have the rights and privileges as are set forth in the Security Agreement.

NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, the Agent hereby releases the Security Interest without recourse or warranty to the Agent, and hereby, (i) waives and relinquishes all its rights, powers, privileges, and remedies with respect to the Trademarks under the Security Agreement pursuant to which such Security Interest was granted to the Trademarks, (ii) sells, assigns, conveys, and transfers over to the Company any right title, or interest that the Agent may have acquired and re-vest in the Company the full unencumbered title to the Trademarks and the goodwill associated therewith, and (iii) releases the Company from all covenants, obligations, liabilities, and warranties with respect to the Trademarks under the Security Agreement to which such Security Interest was granted.
