ARTICLES OF AMENDMENT TO
THE ARTICLES OF INCORPORATION
OF
AV-AIR, INC.
an Arizona corporation

Pursuant to Title 10, Chapter 10 of the Arizona Revised Statutes, the undersigned corporation adopts these articles of amendment:

1. The name of the corporation is Av-Air, Inc.
2. The articles of incorporation filed with the Arizona Corporation Commission on May 30, 2000, as amended July 13, 2000, are hereby further amended by deleting Article I and inserting the following in place thereof:

"Article I
The name of the corporation is AvAir, Inc."
3. These articles of amendment do not provide for an exchange, reclassification or cancellation of issued shares.
4. The amendment was adopted by the shareholders and the board of directors of the corporation on March 28, 2014, in the manner prescribed by A.R.S. § 10-1003.
5. As of the date of adopting the amendment, there were 100 shares of voting common stock outstanding and entitled to vote. There were 100 votes for and 0 against approval of the amendment. The number of votes cast for approval of the amendment was sufficient for approval of the amendment.
