## NUNC PRO TUNC TRADEMARK ASSIGNMENT

This Nunc Pro Tunc Trademark Assignment Agreement (“Assignment”) is by and between Omniflex Limited Partnership, a Massachusetts limited partnership with a place of business at 64 Adams Road, P.O. Box 1167, Greenfield, Massachusetts 01302 (“Assignor”) and Argotec LLC, a Delaware limited liability company, with a place of business at 53 Silvio O. WHEREAS, Assignor is the owner of the mark VACUFLEX and the corresponding U.S. Trademark Registration No. 1,833,836 (hereinafter collectively referred to as the “Mark”)

WHEREAS, Assignor desires to transfer all right, title and interest in and to the Mark to Assignee as of May 31, 2013; and

WHEREAS, Assignee desires to acquire all of the Assignor’s right, title and interest in and to the Mark as of May 31, 2013.

In consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign, *nunc pro tunc*, as of May 31, 2013, unto Assignee, all of Assignor’s right, title, and interest in and to the Mark, together with all goodwill, and the right to sue third parties for and recover damages from past and future infringement of the Mark.

All covenants and obligations herein shall be binding on and inure to the benefit of the Assignor, Assignee and their respective successors and permitted assigns.

Assignor hereby authorizes the Commissioner of Patents and Trademarks of the United States, and any official of any other country empowered to issue trademark registrations, to record this Assignment, and to issue or transfer said Registration and


Mark to the Assignee as owner of all right, title and interest therein, or otherwise as the Assignee may direct, in accordance with the terms of this Assignment.


