ASSIGNMENT OF TRADEMARK

THIS ASSIGNMENT OF TRADEMARK (the "**Assignment**") dated as of this 25 day of June, 2014, is made and entered into by and between **Cromaglass Corporation**, a Pennsylvania corporation with a business address of P.O. Box 3215, Williamsport, Pennsylvania 17701 and **Mike Oleyar, Esq., Chapter 7 Trustee M.D. of PA.**, with an address of 1363 N. Church Street, Hazle Township, Pennsylvania 18202 (the "**Assignors**"), and **Zoeller Pump Company, LLC**, a Kentucky limited liability company with a business address of 3649 Cane Run Road, Louisville, Kentucky 40211 (the "**Assignee**").

RECITALS:

- A. Cromaglass Corporation, a Pennsylvania corporation with a business address of P.O. Box 3215, Williamsport, Pennsylvania 17701, adopted and used in its business the trademark, CROMAGLASS (the "**Trademark**") in the United States, Costa Rica, Mexico, Trinidad and Tobago.
- B. On August 15, 1990, Cromaglass Corporation filed an application with the USPTO for registration of the Trademark, U.S. Application Serial No. 74/088,183 in a stylized form. On December 31, 1991 Cromaglass Corporation obtained Trademark Registration No. 1,670,157 (the "**Registration**") for the Trademark.
- C. Cromaglass Corporation has or may have also obtained a registration or registrations for the Trademark in Costa Rica, Mexico, Trinidad and Tobago.
- D. Cromaglass Corporation has been or is currently in bankruptcy with Mike Oleyar, Esq. acting as Chapter 7 Trustee M.D. of PA. His address and telephone number are 1363 N. Church Street, Hazle Township, Pennsylvania 18202, (570) 455-6800 (the "**Trustee**").
- E. Therefore, Cromaglass Corporation and/or Mike Oleyar, Esq. as Trustee, are currently the legal owner or owners of the Registration, the Trademark, trademarks and registrations in Costa Rica, Mexico, Trinidad and Tobago, and all rights related thereto.

NOW, THEREFORE, in consideration of the terms and conditions of this Assignment, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties to this Assignment do hereby agree as follows:

1. Assignment of Trademark and Registration. Assignor and Trustee do hereby assign, transfer, convey and set over to the Assignee its entire interest in the Trademark, the Registration and trademarks and registrations in Costa

Rica, Mexico, Trinidad and Tobago, together with the goodwill of the business in connection with which such Trademark is used.

2. Acceptance of Assignment. Assignee does hereby accept the assignment made by Assignor and Trustee.
3. Benefit. This Assignment shall be binding upon and inure to the benefit of the parties to this Assignment and the successors and assigns of the parties to this Assignment.
