## TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Trademark Assignment"), effective *nunc pro tunc* as of June 27, 2014, ("Effective Date") is by and between Insolvency Services Group, Inc., a California corporation, with offices at 9107 Wilshire Blvd, Suite 800, Beverly Hills, California 90210 ("Assignor") and Unique Beverages (USA) Inc., a Delaware corporation with offices at c/o Burns & Levinson LLP 125 Summer Street, Boston, Massachusetts 02110 ("Assignee").

WHEREAS, Assignor has obtained, pursuant to that certain General Assignment (the "ABC Agreement") between The Rising Beverage Company, LLC ("RBC") and Assignor for the benefit of RBC's creditors and that certain Trademark Assignment between RBC and Assignor (the "RBC Trademark Assignment"), all of RBC's right title and interest in and to RBC's trademarks, both registered and at common law, including but not limited to those common law, registered marks and/or pending applications for trademarks shown on the attached Schedule A (collectively, the "Marks"), together with the goodwill related thereto, and of all rights not previously assigned in and to any copyrights and copyrightable subject matter, compiled designs, processes, information, technical knowhow, data, trade secrets, improvements, discoveries, notes, memoranda, specifications, drawings, marketing plans, brochures and other intangible property (other than patents) (the "Intellectual Property");

WHEREAS, Assignor and Assignee are entering into that certain Asset Purchase Agreement dated June 27, 2014 (the "Asset Purchase Agreement");


WHEREAS, consistent with the Asset Purchase Agreement and the transfer from Assignor to Assignee thereunder of all of RBC's goodwill and assets assigned to Assignor, Assignee is desirous of acquiring, and Assignor is desirous of transferring, the entire right, title and interest in and to the Marks, the Intellectual Property and the goodwill of RBC's business in connection with which the aforesaid Marks and Intellectual Property have been used;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor, pursuant to the Asset Purchase Agreement, hereby assigns, transfers and sets over to Assignee, its successors, legal representatives and assigns, the entire right, title, and interest of Assignor in and to said Marks, together with the Intellectual Property and the goodwill of RBC's business connected with the use of the Intellectual Property and the use of and symbolized by the Marks, and all claims, if any, which may have arisen thereunder prior to the date of this instrument.



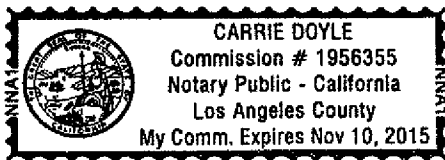
