## RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of October 15, 2014, by Agility Capital II, LLC, a California limited liability company ("Lender") in favor of McCrane, Inc., a California corporation ("Company") with its principal place of business located at 801 Chadbourne Road, Suite 103, Fairfield, CA 94534.
