**RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (this "Release"), is made effective as of August 11, 2014 by and from U.S. BANK NATIONAL ASSOCIATION, as agent (the "Grantee"), in favor of C & K MARKET, INC., an Oregon corporation ("Market"), and C&K EXPRESS, LLC, an Oregon limited liability company ("Express", and together with Market, each a "Grantor" and collectively, the "Grantors").

WHEREAS, the Grantors and the Grantee entered into that certain Trademark Security Agreement (the "Trademark Security Agreement"), dated as of October 28, 2010, pursuant to which the Grantors granted the Grantee a security interest in all of the Grantors' trademarks as set forth on Schedule 1 of the Trademark Security Agreement, and attached hereto as Schedule 1 (the "Trademark Collateral"), as security for the payment and performance of certain obligations, as described in the Trademark Security Agreement;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 4, 2010 at Reel 4410, Frame 0001; and

WHEREAS, the Grantee has duly authorized the execution, delivery and performance of this Release and the recording thereof;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee agrees as follows:


SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release have the meanings provided in the Trademark Security Agreement.

SECTION 2. Release of Security Interest. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby releases its security interest in and continuing lien on all of each Grantor's right, title and interest in, to and under the Trademark Collateral, including, without limitation, the Trademarks listed on Schedule 1 of the Trademark Security Agreement and attached hereto as Schedule 1, and assigns such security interest and lien to such Grantor (as applicable). Grantee represents and warrants that: (a) it has full power and authority to execute this Release; and (b) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has in the Trademark Collateral. Grantee hereby authorizes each Grantor and its agents and designees to make the filings necessary to record and evidence the termination, cancellation and release of the security interests in and liens on the Trademark Collateral.

SECTION 3. Release of the Trademark Security Agreement. This Release has been executed and delivered by the Grantee for the purpose of releasing the security interest of the Grantee in the Trademark Collateral in the United States Patent and Trademark Office and worldwide.
