**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of October 2, 2014, from JPMORGAN CHASE BANK, N.A., as Administrative Agent (the "Agent") for certain banks and other financial institutions (the "Lenders"), to SKIPPACK CREEK CORPORATION, a Delaware corporation with its principal place of business located at 1770 Promontory Circle, Greeley, CO 80634 ("Grantor").

WITNESSETH:

WHEREAS, pursuant to the Guarantee and Collateral Agreement, dated as of May 27, 2011, made by the Grantor in favor of the Agent (the "Guarantee and Collateral Agreement"), a security interest (the "Security Interest") was granted by the Grantor to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Trademark Security dated as of May 27, 2011, between the Agent and Grantor (the "Trademark Security Agreement"), Grantor, by reference to the Guarantee and Collateral Agreement, reaffirmed its intent to grant a Security Interest to the Agent specifically in certain Trademark Collateral;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on June 30, 2011 at Reel 4572 and Frame 0612; and

WHEREAS, the Agent now desires to terminate and release its Security Interest solely with respect to the Trademarks listed on Exhibit A hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, the Agent hereby releases, terminates and discharges the Security Interest granted under the Trademark Security Agreement solely with respect to the Trademarks listed on Exhibit A hereto, and any right, title or interest of the Agent in such Security Interest granted under the Trademark Security Agreement solely with respect to the Trademarks listed on Exhibit A hereto shall hereby terminate, cease and become void. The Agent hereby consents to the recording of this Release with the United States Patent and Trademark Office and agrees to duly execute and deliver any further documents and do such other acts as may be reasonably necessary to effect the release of the Security Interest solely with respect to the Trademarks listed on Exhibit A as contemplated hereby.
