IP SUPPLEMENT

This IP SUPPLEMENT, dated September 23, 2014, is delivered pursuant to and supplements (i) the Security Agreement, dated as of July 26, 2007, as amended by that certain First Amendment to Security Agreement, dated as of January 25, 2008, that certain Second Amendment to Credit Agreement and Amendments to Loan Documents, dated as of March 25, 2011, that certain IP Supplement, dated as of March 25, 2011, and that certain Fourth Amendment to Credit Agreement and Amendments to Loan Documents, dated as of April 19, 2013 (as it may be from time to time further amended, modified, restated or supplemented, the **“Security Agreement”**), among Isle of Capri Casinos, Inc., a Delaware corporation (**“Grantor”**), the other Grantors named therein, and Wells Fargo Bank, National Association (as successor to Credit Suisse AG, Cayman Islands Branch (f/k/a Credit Suisse, Cayman Islands Branch)), as Secured Party, and (ii) the Grant of Trademark Security Interest dated as of April 19, 2013 (the **“Grant”**) executed by Grantor. Capitalized terms used herein not otherwise defined herein shall have the meanings ascribed thereto in the Grant.

Grantor grants to Secured Party a security interest in all of Grantor’s right, title and interest in and to the Trademark Collateral listed on Schedule A attached hereto in accordance with the terms and provisions of the Security Agreement. All such Trademark Collateral shall be deemed to be part of the Trademark Collateral and shall be hereafter subject to each of the terms and conditions of the Security Agreement and the Grant.


