RELEASE OF GRANT OF SECURITY INTEREST

THIS RELEASE OF GRANT OF SECURITY INTEREST (this "Release") is given on October 16, 2014, by REGIONS BANK, in its capacity as Collateral Agent for the Secured Parties (the "Collateral Agent"), to THE LASIK VISION INSTITUTE, LLC (the "Grantor").

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent & Trademark Office on March 13, 2014 at reel/frame 5236/0807; and





