## TERMINATION AND RELEASE OF IP SECURITY AGREEMENTS

**THIS TERMINATION AND RELEASE OF IP SECURITY AGREEMENTS** (this "Termination"), is dated as of October 2, 2014, and made by **FIRSTMERIT BANK, N.A.**, having an office at 3 Cascade Plaza, 2<sup>nd</sup> Flor, Akron, OH 44308 ("Grantee") to **OLD TIME POTTERY, LLC**, a Tennessee limited liability company formerly known as Old Time Pottery, Inc. ("Grantor"), having an office at 480 River Rock Blvd., Murfreesboro, TN 37128.

WHEREAS, pursuant to (1) that certain Grant of Security Interest in United States Trademarks dated May 28, 2010 made by Grantor in favor of Grantee (the "Trademark Security Agreement"), and (2) such documents as Grantee may have recorded with the United States Copyright Office (the "Copyright Office") to evidence Grantee's lien on copyrights owned by Grantor (collectively, the "Copyright Security Agreement" and together with the Trademark Security Agreement, collectively the "IP Security Agreements"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Trademark Collateral (as hereinafter defined) and the Copyright Collateral (as hereinafter defined);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office (the "USPTO") on June 15, 2010, at Reel 4225 and Frame 0504; and

WHEREAS, Grantee now desires to terminate and release the IP Security Agreements;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean and include all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks and trademark applications listed on Schedule A hereto. The term "Copyright Collateral," as used herein, shall mean and include all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the copyrights and copyright applications listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the IP Security Agreements and terminates, cancels, releases and discharges the mortgage, pledge and hypothecation and lien on and security interest in and to the right, title and interests in, to and under all of the Trademark Collateral and Copyright Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademark Collateral and the Copyright Collateral and any right, title or interest of the Grantee in such Trademark Collateral and Copyright Collateral shall hereby cease and be void.

3. Authorization. Grantee authorizes the recordation of this Termination with the USPTO and the Copyright Office at Grantor's expense by Grantor or its authorized designees.
