

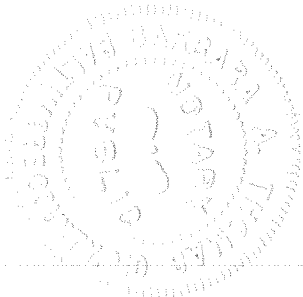


RESOLVED: That the CEO, Marvin C. Mather, III of the Corporation is hereby authorized to execute any documents to support this transaction; and
