CORRECTION AND *NUNC PRO TUNC* TRADEMARK RE-ASSIGNMENT

Robert T. Wagner, an individual and citizen of the United States; ("Assignor"), for good and valuable consideration, receipt of which is acknowledged, formally re-assigns *nunc pro tunc* effective June 4, 2013 to The American Export Group & International Services, Inc., a Delaware corporation dba AEGIS, Inc., located at 2424 Dempster Drive, Coralville, IA, USA 52241 ("Assignee"), all of his rights, title, and interest in and to the trademark INTENSIVE LASH AND BROW TINT and its accompanying U.S. Trademark Registration No. 3,401,272 together with any goodwill of that portion of Assignor's business symbolized by this trademark not already owned by Assignee. Assignor also hereby re-assigns his rights and interests, along with the accompanying goodwill not already owned by Assignor, in all of Assignor's common law trademarks that include the term INTENSIVE.

This "re-assignment" intends to formally make a correction in the name of the owner of the subject registration as stated in a previously recorded Assignment. This correction will correct an inadvertent mistake by the owner/Assignor of the registration that occurred in good faith. This mistake relates to the manner in which the Assignee's name was set forth in the assignment dated June 4, 2013 that was duly recorded at the US Trademark Office.

The owner information of the Assignee that was misstated in the earlier assignment was an inadvertent mistake, which was made in good in faith through the fault of Robert T. Wagner, the previous owner of record (the Assignor in that previous assignment and the Assignor herein) and a corporate officer of the Assignee. Robert T. Wagner inadvertently and mistakenly had the previous assignment document identify the Assignee by the Assignee's "dba" or trade name, AEGIS, Inc., instead of the proper registered Delaware corporation entity name, The American Export Group & International Services Inc.




