RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (the "Release"), is made and effective as of October 17, 2014 between Human Movement Inc. f/k/a Human Movement LLC, a Delaware corporation, located at 1111 South Street, Louisville, CO 80027 ("Human Movement") and Alta HMM Bridge Investors LLC, a Delaware limited liability company, located at 1000 Winter Street, Suite 3500, Waltham, MA 02451 ("Alta").

1. Alta, on behalf of itself, its successors, legal representatives and assigns, terminates, releases and discharges its Security Interest in and to the Trademarks, and all other right, title, and interest in and to the Trademarks.

2. Alta agrees to execute, acknowledge, procure and deliver to Human Movement any and all further documents or instruments and do any and all further acts which Human Movement (or its respective agents, designees or assignees) reasonably request in order to confirm, effectuate or record this Release and Human Movement's (or its assignees') right, title and interest in and to the Trademarks.
