RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN UNITED STATES TRADEMARKS (this “Release”) is made as of October 20, 2014 (“Effective Date”) in favor of PRO Corporation (f/k/a PRO Operating, Inc. (f/k/a Comforce Operating, Inc.)) (“Grantor”) and CITIZENS BUSINESS CAPITAL, a division of Citizens Asset Finance, Inc. (the “Agent”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Loan Agreement (as defined below).

WHEREAS, Grantor and the Agent entered into that certain Loan and Security Agreement by and between Grantor, the Agent and the other parties thereto dated January 19, 2012 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Loan Agreement”);

WHEREAS, pursuant to the Loan Agreement, Grantor granted to the Agent a security interest in and to certain intellectual property, and entered into that certain Intellectual Property Security Agreement dated January 19, 2012 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Intellectual Property Security Agreement”) for the purpose of recording such security interest with respect to the trademarks, with the United States Patent and Trademark Office; and

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on January 20, 2012, at Reel 4701, Frame 0506.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby, on behalf of itself and the Lenders (i) terminates, cancels and releases any and all security interests it has against the trademarks identified in **Schedule A**, and (ii) re-assigns to Grantor any right, title and interest it may have in, to and under such trademarks.

The Agent shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.


This Release shall be governed by and construed in accordance with the laws of the State of New York.
