TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "*Assignment*") is entered into as of November 15, 2011 (the "*Effective Date*") by Jim L. Venable, an adult individual, and Jim Venable Co. (d/b/a Window Depot USA and Window Depot USA, Inc.) (herein collectively the "*Assignors*") in favor of Window Depot Global, LLC, an Ohio limited liability company ("*Assignee*").

Background

Assignors have adopted, used and are using certain trademarks and trade names set forth on **Schedule A** attached hereto (the "*Marks*"), each of which is registered in the U.S. Patent and Trademark Office. Assignors own all right, title and interest to the Marks, including the goodwill associated therewith.

The Assignors and Assignee have executed that certain **Asset Purchase Agreement** dated as of the date hereof (the "*Agreement*") pursuant to which Assignors have agreed to sell, transfer and assign certain intellectual property rights and other assets to Assignee, including, without limitation, the Marks. In accordance with the further terms of the Agreement, Assignors hereby desire to assign to Assignee all right, title and interest in and to the Marks, including the goodwill associated therewith and the registrations thereof.

Agreement

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which Assignors expressly acknowledge:

1. Assignors hereby assign, transfer and deliver to Assignee all of their respective rights, title and interest in and to the Marks, including, without limitation, the U.S. registrations thereof and the goodwill of the business symbolized thereby. Assignors further assign to Assignee all rights to sue, bring actions and recover and hold damages, profits and other compensation for any and all past, present and future infringements and unauthorized uses of the Marks.

2. Assignors covenant and agree that Assignors shall, at the request of Assignee or its counsel, execute, acknowledge and deliver all such further acts, deeds, assignments, transfers, powers of attorney and assurances as may be required to carry out the intent of this Assignment, and to transfer and vest title in and to the Marks and to procure, maintain, enforce and protect the right, title and interest in and enjoyment of the Marks assigned, transferred and conveyed to Assignee pursuant to this Assignment; provided, however, that this Assignment shall be effective regardless of whether any such additional documents are executed.


3. This Assignment shall be binding upon and shall inure to the benefit of Assignors and Assignee and their respective successors, legal representatives and

4. A facsimile or photocopied signature (which may be delivered by facsimile or other electronic means) shall be deemed to be the functional equivalent of an original for all purposes.



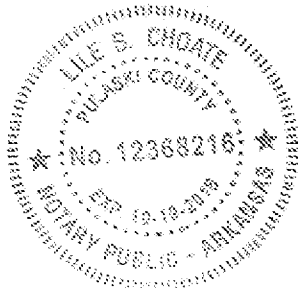

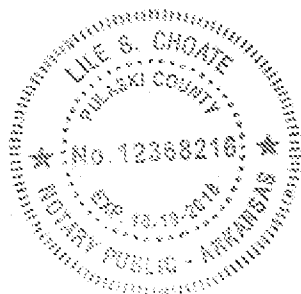
