**RELEASE OF SECURITY INTEREST – U.S. TRADEMARKS**

THIS RELEASE is given as of October 20, 2014 by Medley Capital Corporation, a corporation organized under the laws of Delaware located at 600 Montgomery Street, 39<sup>th</sup> Floor, San Francisco, California 94111, agent for lenders and various lenders (collectively “the “**Lender**”) to GSG Fasteners, LLC, a limited liability company organized under the laws of the State of Delaware, with an address at 1802 Scovill Drive (P.O. Box 44), Clarkesville, Georgia 30523-0044 (the “**Borrower**”).

WHEREAS the Borrower and the Lender entered into an agreement entitled “Trademark Collateral Security Agreement” dated November 18, 2013 (the “**Security Agreement**”), pursuant to which the Borrower assigned, transferred, conveyed, and granted a security interest to the Lender in certain property, and, by way of mortgage and charge, granted a security interest to the Lender in proceeds arising from that property;

AND WHEREAS that property and proceeds included the trademarks set forth in Schedule A and licenses set forth in Schedule B of the Security Agreement;

AND WHEREAS the Borrower is the owner of the trademarks set forth in Schedule A attached hereto, together with all goodwill associated therewith and all applications, registrations and renewals in connection therewith;

AND WHEREAS the Borrower is party to the licenses set forth in Schedule B attached hereto;


AND WHEREAS the Lender recorded the Security Agreement with the United States Patent and Trademark Office at Reel 005156 and Frame 0057 for the Trademarks listed on Schedule A on November 18, 2013;

AND WHEREAS the Lender now desires to release its entire security interest in the trademarks set forth on Schedule A;

NOW THEREFORE in consideration of the sum of one dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the parties hereto:

1. The Lender hereby releases and discharges all of its claims, rights, title, interest, and benefit, if any, including the aforementioned security interests, in, to, and under the trademarks and licenses set out in Schedule A and Schedule B, respectively.
