## **Trademark and Trade Name Assignment**

**WHEREAS**, Assignor owns and is using a United States trademark and trade name, including without limitation the trademark registration and trade name registration identified and set forth in Exhibit A attached hereto, together with the goodwill of the business associated therewith and symbolized thereby (collectively, the "Property"); and

**WHEREAS**, pursuant to that certain Asset Purchase and Sale Agreement by and between Assignor and Assignee, dated as of October 13, 2014 (the "Purchase Agreement"), Assignor agreed to assign to Assignee the entire right, title and interest in and to all of its Property and all goodwill associated therewith and symbolized thereby.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, transfers and delivers to Assignee the entire right, title and interest of Assignor in and to all of its Property, together with the goodwill associated therewith and symbolized thereby.

Assignor hereby authorizes and requests the officials of the United States Patent and Trademark Office and of the several states, to record Assignee as the owner of and/or to issue in accordance with this instrument all registrations of the Property and all applications for any of the same, which are assigned to Assignee by this instrument.

This Assignment and all questions relating to its validity, interpretation, performance and enforcement shall be governed and construed in accordance with the laws of the Commonwealth of Pennsylvania.

This Assignment shall inure to the benefit of Assignee and its successors and assigns and shall be binding upon Assignor and its successors and assigns.

Notwithstanding anything herein to the contrary, the terms and conditions of the Purchase Agreement shall survive the execution and delivery of this Assignment to the extent provided therein.

This Assignment is subject in all events to the terms and conditions of the Purchase Agreement. In the event of a conflict or inconsistency between this Assignment and the Purchase Agreement, the terms of the Purchase Agreement shall prevail.

The covenants and agreements contained herein shall be binding upon and inure to the benefit of the parties hereto and their respective successors and permitted assigns, and are for the sole benefit of the parties hereto and their respective successors and permitted assigns. Such covenants and agreements shall not be construed as conferring and are not intended to confer any rights or benefits on any other person.

This Assignment may be executed in two or more counterparts and by facsimile, and by the different parties hereto in separate counterparts, each of which when executed shall be deemed to be an original, but all of which shall constitute one and the same agreement.


