## TRADEMARK RELEASE AND REASSIGNMENT

This Trademark Release and Reassignment is made as of October 21, 2014, by FirstMerit Bank, N.A. ("Grantee").

### WITNESSETH:

WHEREAS, Grantee and TMI International, LLC, a Delaware limited liability company ("Grantor"), are parties to that certain Trademark Security Agreement dated as of September 26, 2013 (the "Agreement") pursuant to which Grantor granted a security interest to Grantee in the Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Grantee;

WHEREAS, the Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on September 30, 2013 at Reel 5119 Frame 0969;

WHEREAS, Grantor has requested that Grantee release its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral and reassign the same to Grantor; and

WHEREAS, Grantee has agreed to release the entirety of its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases its security interest in and lien on all of Grantor's right, title and interest in the following (collectively, the "Trademark Collateral"):

(i) each trademark and trademark application, including, without limitation, each trademark and trademark application referred to in Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof and all goodwill associated therewith;

(ii) each trademark license, including, without limitation, each trademark license listed on Schedule 1 annexed hereto, together with all goodwill associated therewith; and

(iii) all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future infringement of any trademark, including, without limitation, any trademark referred to in Schedule 1 annexed hereto, any trademark issued pursuant to a trademark application referred to in Schedule 1 and any trademark licensed under any trademark license listed on Schedule 1 annexed hereto.

2. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, all of Grantee's right, title and interest (if any) in and to the Trademark Collateral.
