DISCHARGE OF SECURITY INTEREST
(Trademarks)

WHEREAS, PARADIGM PACKAGING, INC., a Delaware corporation (the “Grantor”), granted a security interest in the United States trademarks listed in Exhibit A attached hereto and in the other collateral (collectively, the “Collateral”) described in the Second Amended and Restated Pledge and Security Agreement and Irrevocable Proxy dated as of February 11, 2014 (the “Security Agreement”) to U.S. BANK NATIONAL ASSOCIATION, a national banking association (the “Grantee”), in order to secure repayment of certain amounts owing to Grantee and the other lenders (the “Lenders”) from time to time party to that certain Second Amended and Restated Credit Agreement dated February 11, 2014 among Scandia Plastics, LLC, a Delaware limited liability company (“Scandia”), Paradigm-Graham Holding Company, a Delaware corporation (“Paradigm Holding”), the Grantor, Paradigm Packaging West, LLC, a California limited liability company (“Paradigm West”), Paradigm Packaging East, LLC, a New Jersey limited liability company (“Paradigm East”) and Precision Medical, Inc., a Georgia corporation (“Precision” and together with Scandia, Paradigm Holding, the Grantor, Paradigm West, and Paradigm East, each a “Borrower” and collectively, the “Borrowers”), and the Lenders, as amended, restated, or otherwise modified from time to time (the “Credit Agreement”);

WHEREAS, a Confirmatory Grant of Security Interest in Trademarks (the “Confirmatory Grant”) between the Grantor and the Grantee with respect to the marks listed in Exhibit A was entered into on December 18, 2013, and was recorded in the records of the United States Patent and Trademark Office (the “USPTO”) on December 27, 2013, and such recordation is located on Reel 5183 at Frame 0075 of the USPTO; and

WHEREAS, the Grantee desires to release the marks listed in Exhibit A from the Confirmatory Grant.

NOW THEREFORE, to all who it may concern be it known that for and in consideration of the payment to the Grantee of the full amount of the indebtedness described in the Credit Agreement, the Grantee hereby (a) releases and discharges all the security interests granted by the Security Agreement, being the security interests granted in respect of the patents, trademarks, copyrights and all other Collateral and (b) acknowledges, confirms and agrees that the Confirmatory Grant is discharged, released and terminated and of no further force or effect.
