RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN THE UNITED STATES TRADEMARKS ("Release") is made effective as of October 23, 2014 ("Effective Date"), by Credit Suisse AG, Cayman Islands Branch, for itself as Administrative Agent and Collateral Agent to the Secured Parties (the "Administrative Agent") to and in favor of Sutherland Global Services Inc., (the "Grantor"), as provided below. Capitalized terms used but not otherwise defined herein are used with the meanings assigned to such terms in the Security Agreement (as defined below).

WHEREAS, on March 6, 2013, Grantor, certain Subsidiaries of the Grantor and the Administrative Agent entered into a U.S. Guarantee and Collateral Agreement (as further amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, on March 6, 2013, Grantor executed in favor of the Administrative Agent a Trademark Security Agreement (the "Trademark Security Agreement");

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, Grantor granted to the Administrative Agent, to secure the Secured Obligations, a continuing security interest in all of Grantor's right, title, and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), whether then owned or thereafter acquired or arising, including, without limitation, each Trademark identified in Schedule A hereto;

WHEREAS, the Trademark Agreement was recorded in the United States Patent and Trademark Office on March 7, 2013, at reel/frame 4978/0086; and

WHEREAS, Administrative Agent wishes to release its security interest in the Trademark Collateral (as defined in the Trademark Agreement).

NOW THEREFORE, as Grantor has satisfied the Secured Obligations under said Security Agreement and Trademark, the Administrative Agent hereby releases, relinquishes, and discharges all of its continuing security interest in the Trademark Collateral, and reassigns any and all interest the Administrative Agent may have in the Trademark Collateral to the Grantor.

The Administrative Agent hereby authorizes the Grantor, or the Grantor's authorized representatives to: (a) record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or Agency, and (b) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the continuing security interest of the Administrative Agent in the Trademark Collateral. The Administrative Agent agrees to execute and deliver to the Grantors all other instruments and other documents as may be necessary or proper to release the continuing security interest in the Trademark Collateral which had been granted under the Trademark Security Agreement.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
