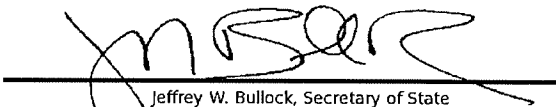

CERTIFICATE OF INCORPORATION**

**MS ACQUISITION CORP.** (the "Corporation"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "DGCL"), hereby adopts the following Certificate of Amendment to its Certificate of Incorporation and,

**DOES HEREBY CERTIFY:**

**FIRST:** The name of the Corporation is MS Acquisition Corp.

**SECOND:** The Board of Directors of the Corporation adopted resolutions approving the amendment and restatement of Section (a) of Article I of the Certificate of Incorporation of the Corporation to read, in its entirety, as follows:

**"ARTICLE I**

Name

(a) The name of the corporation is **MANUFACTURING SOLUTIONS INDUSTRIES, INC.** (the "Corporation")."
