AMENDMENT NO. 2 TO

AMENDED AND RESTATED CERTIFICATE OF INCORPORATION
OF
TST MEDIA, INC.

TST Media, Inc., a corporation organized and existing under the General Corporation Law of the State of Delaware (the "Company"), does hereby certify as follows:

FIRST: The Company's Amended and Restated Certificate of Incorporation was filed with the office of the Secretary of State of the State of Delaware on February 21, 2014 (the "Certificate of Incorporation").

SECOND: This Amendment of the Certificate of Incorporation of the Company, in the form set forth below, has been duly adopted in accordance with the provisions of Sections 228 and 242 of the General Corporation Law of the State of Delaware by the directors and stockholders of the Company.

THIRD: Article 1 of the Certificate of Incorporation of the Company is hereby amended and restated to read in its entirety as follows:

"The name of this corporation is Sport Ngin, Inc. (the "Corporation")."


FOURTH: The Certificate of Incorporation of the Company is hereby amended by adding a new Article 11 to read in its entirety as follows:

"Unless the Corporation consents in writing to the selection of an alternative forum, the Court of Chancery of the State of Delaware shall be the sole and exclusive forum for (A) any derivative action or proceeding brought on behalf of the Corporation, (B) any action or proceeding asserting a claim of breach of a fiduciary duty owed by any director, officer, employee or agent of the Corporation to the Corporation or the Corporation's stockholders, (C) any action or proceeding asserting a claim against the Corporation arising pursuant to any provision of the Delaware General Corporation Law or the Corporation's Certificate of Incorporation or Bylaws, or (D) any action or proceeding asserting a claim governed by the internal affairs doctrine, in each case subject to said Court of Chancery having personal jurisdiction over the indispensable parties named as defendants therein."
