WHEREAS, the May 21, 2014 assignment incorrectly stated that the basis for the assignment of the Mark was the passage of time and "the Illinois law of interstate cessation."

WHEREAS, the correct basis for the assignment of the Mark is Registrant's death on September 23, 2012, and the passage of certain of his assets, including the Mark, to his surviving spouse, Sudha S. Mahurkar, as Trustee of the Sudha S. Mahurkar Trust, dated October 30, 1992 ("Assignee"), pursuant to the will and trust documents governing the estate.

WHEREAS, pursuant to Registrant's will and trust documents governing Registrant's estate, Registrant, through its legal representative, transfers to Assignee all of Registrant's right, title, and interest in and to the Mark.

WHEREAS, Assignee desires to acquire from Registrant all of Registrant's right, title, and interest in and to the Mark.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Registrant, through its legal representative, does hereby assign unto Assignee all of Registrant's right, title, and interest in, to and under the Mark, together with the goodwill of the business associated with the use of and symbolized by such Mark, and the right to sue and bring action for any and all infringements and unauthorized use of said Mark, if any, which may have arisen thereunder prior to the date of this instrument.

ASSIGNMENT OF AFFIDAVIT OF DEATH

The property of Decedent which passed to Declarant includes all of Decedent's right, title and interest in and to the registered trademark MAHURKAR, U.S. Trademark Registration No. 1,841,750 together with the goodwill of the business carried on in association with this mark.

No other person has a right to the interest of the Decedent in the above-described property.

Declarant therefore requests that the records of the U.S. Patent and Trademark Office reflect the fact that the interest of Decedent in the described property is now owned by Declarant.

Declarant declares under penalty of perjury under the laws of the State of Illinois that the foregoing is true and correct.
