**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of October 28, 2014, and made by ONEWEST BANK N.A. (formerly known as OneWest Bank, FSB), in its capacity as administrative agent for the Lenders (as defined in the Security Agreement (as hereinafter defined)) ("Grantee") to TEASDALE FOODS, INC. (f/k/a HOOPESTON FOODS, INC.) ("Grantor").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of August 31, 2012 made by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain Collateral (as defined in the Security Agreement), including the Trademarks (as defined in the Security Agreement);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on August 31, 2012, at Reel 4853 and Frame 0657; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

Release of Security Interest. Grantee, on behalf of itself and on behalf of the other Creditor Parties (as defined in the Security Agreement), hereby terminates the Security Agreement and terminates releases and discharges the security interest in the Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Collateral.
