## RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (the “Release”) is made effective as of October 9, 2014, by JPMORGAN CHASE BANK, N.A., as Collateral Agent (the “Collateral Agent”) to MEASUREMENT SPECIALTIES, INC. (the “Grantor”) as follows:

WHEREAS, the Grantor, certain Subsidiaries of the Grantor, and the Collateral Agent for the Secured Parties are parties to that certain Pledge and Security Agreement dated as of June 1, 2010 (as may be amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, the Grantor was required to execute and deliver a Confirmatory Grant of Security Interest in United States Trademarks dated as of June 1, 2010, October 8, 2010, January 18, 2013, May 16, 2013, and April 3, 2014 (collectively the “Trademark Agreements”) to the Collateral Agent in order to secure the prompt and complete payment, observance and performance of all of the Secured Obligations in accordance with the terms and conditions of the various loan documents;

WHEREAS, pursuant to the Trademark Agreements, the Grantor granted to the Collateral Agent, among other collateral, a continuing security interest in all of the Grantor’s right, title and interest, including goodwill, in, to and under the United States Trademarks listed on the attached Schedule A (the “Marks”);

WHEREAS, the Trademark Agreements were recorded in the United States Patent & Trademark Office on June 1, 2010 at Reel/Frame 4216/0104, on October 14, 2010 at Reel/Frame 4296/0291, on January 18, 2013 at Reel/Frame 4945/0816, on May 17, 2013 at Reel/Frame 5030/0338, and on April 4, 2014 at Reel/Frame 5251/0877; and


WHEREAS, the Collateral Agent wishes to release its security interest in the Marks.

NOW THEREFORE, as the Grantor has satisfied its Secured Obligations under the Security Agreement, the Collateral Agent hereby terminates, releases and discharges any security interest in and lien upon the Marks, and assigns, transfers, and conveys to the Grantor any and all right, title or interest in, or to, the Marks that the Collateral Agent may hold.
