THIS TRADEMARK ASSIGNMENT is made as of this 25 day of October, 2014, by Qualguard, Inc., a Delaware corporation ("Assignor"), in favor and for the benefit of Mailpix, Inc., a Delaware corporation ("Assignee").

RECITALS

WHEREAS, Assignor has registered the Mark on the Principal Register of the United States Patent and Trademark Office in connection with the above-described goods and/or services, under the Serial Numbers as described on Exhibit A hereto; and

WHEREAS, Assignee desires to acquire the Marks.

NOW, THEREFORE, in consideration of the mutual agreements set forth herein and in the Agreement and of other valuable consideration paid by Assignee to Assignor at the Closing (as defined in the Agreement), the receipt, adequacy and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee all right, title and interest in and to the Marks along with (i) the goodwill of the business symbolized by and/or associated with the Marks, (ii) the registrations of and applications therefor, as applicable, (iii) all reissues, divisions, continuations, continuations in part, substitutes, renewals, and extensions thereof, all improvements thereon, (iv) the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present or future infringements or dilution of or damage or injury to the Marks or such associated goodwill and (v) all other rights of any kind whatsoever of such Assignor accruing thereunder or pertaining thereto.
