The Assignor confirms that the Assignee or their legal representative is authorised to sign on behalf of the Assignor all forms and documents that are required by the OHIM, USPTO or IP Australia to record this assignment at that Registry.

This Assignment shall be governed by English law in every particular including formation and the parties agree to submit to the exclusive jurisdiction of the courts of England and Wales.
