TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment"), effective as of the 31st day of December, 2013, is made and entered into by Solcom, Inc., a South Dakota corporation ("Assignor"), in favor of EDCO Health Information Solutions Inc., a Missouri corporation (the "Assignee").

WHEREAS, Assignor is the owner of the following trademarks and service marks:

- SOLARITY, a standard character mark that is the subject of common law rights and a registration with the U.S. Patent and Trademark Office, Registration No. 3,775,780; and
- SOLCOM, a standard character mark that is the subject of common law rights and a registration with the U.S. Patent and Trademark Office, Registration No. 2,305,241;

WHEREAS, Assignor desires to assign to Assignee, and Assignee desires to acquire from Assignor, all right, title and interest in and to all of the above-identified marks (collectively, the "Marks") and registrations (collectively, the "Registrations"), including, without limitation, all common law rights relating to the Marks and all renewals and extensions that may be granted in connection with the Registrations, together with the goodwill of Assignor's business associated with the Marks and Registrations;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Assignor hereby assigns, sells and sets over to Assignee all right, title and interest in and to the Marks and Registrations, together with the goodwill of Assignor's business symbolized by the Marks and Registrations, and all other rights that Assignor has enjoyed thereunder as trademarks, service marks, trade names, domain names and otherwise, including, without limitation, all rights and remedies based upon past infringement (including the right to sue and collect damages and profits for such infringement).

2. Assignor covenants and agrees that it will, at any time, on request, execute and deliver any and all papers that may be necessary or desirable to perfect the title to the aforementioned assets and rights assigned by this Assignment.
