RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “*Release*”) is made as of October 31, 2014, by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as collateral agent (in such capacity as the “*Collateral Agent*”), to and in favor of WORLEY CLAIMS SERVICE, LLC, a Delaware Limited Liability Company (“*Worley*”).

W I T N E S S E T H:

WHEREAS, Worley and certain other entities executed that certain Guarantee and Collateral Agreement, dated as of July 6, 2012 (the “*Collateral Agreement*”) in favor of the Collateral Agent, and Worley executed that certain Trademark Security Interest Agreement, dated as of July 6, 2012 (the “*Trademark Security Interest Agreement*”), in favor of the Collateral Agent, pursuant to which Worley assigned and pledged a security interest in all of Worley’s right, title and interest in, to and under the Pledged Collateral (as defined in the Collateral Agreement), including all right, title and interest in, to and under the trademarks and registrations therefore set forth in Exhibit A attached hereto; and

WHEREAS, the Trademark Security Interest Agreement was recorded with the United States Patent and Trademark Office at Reel 004817, Frame 0125 on July 9, 2012; and

WHEREAS, the Collateral Agent has agreed to release all of its security interest in all of Worley’s right, title and interest in, to and under the Pledged Collateral, and reconvey any and all rights in the Pledged Collateral to Worley.

NOW, THEREFORE, in consideration of good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent hereby releases, reconveys and relinquishes all of its right, title and interest in, to and under the Pledged Collateral that is the subject of the Trademark Security Interest Agreement and reassigns to Worley any and all right, title or interest it may have in such Pledged Collateral, all without warranty or representation of any kind.

The Collateral Agent hereby authorizes and requests that the United States Commissioner of Patents and Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Release.
