- (6) Assignor is not the subject to any agreement, judgment or order inconsistent with the terms of this Assignment.

Assignor, and any representative, executor and/or administrator of Assignor, will at any time, upon request and without additional consideration but at the expense of Assignee, its successors, and assigns, execute any and all additional writings and do such additional acts as Assignee, its successors, and assigns, may deem desirable to perfect its enjoyment of this Assignment and

grant, and render any and all assistance in making application for and obtaining, maintaining and enforcing the rights granted herein in all countries.

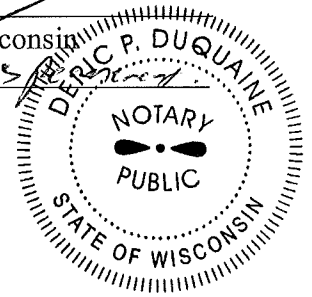
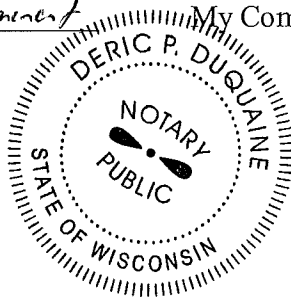
