**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This RELEASE, dated as of November 3, 2014, is made by MORGAN STANLEY SENIOR FUNDING, INC. in its capacity as collateral agent (in such capacity, the "Collateral Agent"), in favor of the Pledgor (as defined below). Capitalized terms not otherwise defined herein have the meaning assigned to them in the Security Agreement.

WHEREAS, Symbion, Inc., a Delaware corporation (the "Pledgor") and the Collateral Agent are parties to that certain Guarantee and Collateral Agreement, dated as of June 14, 2011 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Pledgor executed the Trademark Security Agreement, dated June 14, 2011, and recorded with the U.S. Patent and Trademark Office on June 17, 2011, at Reel/Frame No. 4565/0070 (the "Trademark Security Agreement"), pursuant to which the Pledgor pledged and granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in and to all of its right, title and interest in, to and under the Trademarks of the Pledgor, all goodwill associated with such Trademarks, and all Proceeds of any and all of the foregoing (except to the extent not constituting Collateral);

WHEREAS, pursuant to the Security Agreement, the Pledgor has requested that the Collateral Agent release its security interest in all of its Trademarks.

NOW, THEREFORE, the Collateral Agent hereby TERMINATES, without recourse, representation or warranty, the Trademark Security Agreement, and RELEASES, without recourse, representation or warranty, its lien on and security interest in the Trademarks, including the trademark registrations and applications set forth in Schedule A, attached hereto and incorporated herein by reference.
