Alisia & Co., LLC, a Utah limited liability company, was originally formed in Iowa on or about October 1, 2010, and was domesticated to the State of Utah by the filing of Articles of Domestication and Articles of Organization with the Department of Commerce, Division of Corporations and Commercial Code (the "Division") on or around March 8, 2013. Alisia & Co., LLC desires to change its name to Mialisia & Co., LLC (the "Company"). The undersigned manager of the Company hereby presents these Amended and Restated Articles of Organization of the Company to the Division for filing. These Amended and Restated Articles of Organization have been duly signed and filed in accordance with Section 48-2c-409 of the Utah Revised Limited Liability Company Act (the "Act"), and have been approved and adopted by the members and managers of the Company on May 3, 2013 as required under the Act.
