**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** this "Release") is made as of November 3, 2014 ("Effective Date") by SILICON VALLEY BANK, as Administrative Agent ("Assignee"), in favor of ONLINE HEALTHNOW, INC., a Florida corporation ("Grantor").


**WHEREAS**, Grantor has paid all of its outstanding indebtedness to Assignee.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignee hereby terminates the Trademark Security Agreement and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.

Assignee shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance, reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release (including, without limitation, the execution and delivery of any and all documents or other instruments reasonably requested to effectively effectuate the purposes of this Release).
