RELEASE OF TRADEMARK SECURITY AGREEMENT
AND LOAN SECURITY AGREEMENT

J.P. Morgan Chase, having an office at Chase Tower, 7th Floor, 10 South Dearborn St., Chicago, Illinois 60603 (hereinafter "Chase"), successor to the interest of American National Bank and Trust Company of Chicago, 120 South LaSalle Street, Chicago, Illinois 60603, in the "Trademark Security Agreement" made February 3, 1999 between Breuer Electric Mfg. Co. and American National Bank and Trust Company of Chicago, copy attached as Exhibit A, and the underlying "Loan Security Agreement" of the same date between the same parties, and any and all subsequent Amendments with the "Fourth Amendment to Loan and Security Agreement", by way of example a copy being attached as Exhibit B.


