As of the Effective Date, Assignor hereby sells, assigns, and transfers unto Assignee, absolutely and forever, all rights, title and interest, throughout the world, in and to the Marks, including, without limitation: (a) all common law and statutory rights therein, and specifically including pending applications and the Certificates of Registration duly and legally issued by any trademark office throughout the world, and any and all renewals thereof; (b) the goodwill attaching to the Marks; and (c) all causes of action for any and all previously occurring infringements of the rights being assigned and the right to receive and retain the proceeds relating to those infringements.

Assignor agrees to execute any further papers and to do such other acts as may be reasonably necessary to effectuate the assignment of the Marks to Assignee.
