**RELEASE OF SECURITY INTEREST IN  
TRADEMARK RIGHTS**

This RELEASE, dated as of November 3, 2014, is made by MORGAN STANLEY SENIOR FUNDING, INC., a Delaware corporation, as Administrative Agent (in such capacity, the "Administrative Agent") pursuant to the Second Lien Credit Agreement, dated as of April 11, 2013 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement") and the Second Lien Guarantee and Collateral Agreement, dated as of April 11, 2013 (as amended and restated from time to time, the "Guarantee and Collateral Agreement"). Capitalized terms not otherwise defined herein have the meaning assigned to them in the Guarantee and Collateral Agreement.

**WITNESSETH**

WHEREAS, Midwest Uncuts, Inc., an Iowa corporation, NovaMed Management Services, LLC, a Delaware limited liability company, and Patient Education Concepts, Inc., a Delaware corporation (collectively, the "Grantors") are parties to the Guarantee and Collateral Agreement;

WHEREAS, pursuant to the Guarantee and Collateral Agreement, the Grantors executed the Grant of Security Interest in Trademark Rights – Second Lien dated April 11, 2013 and recorded with the U.S. Patent and Trademark Office on May 3, 2013 at Reel/Frame No. 5020/0929 (the "Grant of Security Interest"), pursuant to which the Grantors granted to the Administrative Agent, on behalf and for the benefit of the Secured Parties, and to secure the prompt and complete payment and performance of all Secured Obligations, a security interest in all of its right, title and interest in, to and under the Grantors' Trademarks;



NOW, THEREFORE, the Administrative Agent hereby TERMINATES, without recourse, representation or warranty the Grant of Security Interest, and RELEASES, without recourse, representation or warranty its security interest in all of the Trademarks, including the trademark registrations and applications set forth in Schedule A, attached hereto and incorporated herein by reference.
