RELEASE OF GRANT OF A SECURITY INTEREST – TRADEMARKS

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of September 23, 2010 (the "IP Security Agreement"), recorded in the United States Patent and Trademark Office at Reel 004287, Frame 0460 on September 30, 2010, AAAA World, Inc., a Florida corporation (f/k/a AAAA World Import-Export, Inc.) 
NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.
2. Release of Security Interest. Releasor hereby, without any representation and warranty, releases, relinquishes and discharges its security interest in the Collateral.
