**Grant of Security Interest

LLC, a Delaware limited liability company (the "Grantor"), having its chief executive office at 401 Broadhollow Road, Melville, NY 11747, hereby confirms that it has granted nunc pro tunc and hereby grants to CANTOR FITZGERALD SECURITIES, as Collateral Agent (the "Grantee"), with offices at 110 East 59th Street, New York, NY 10022, a security interest in all of the Grantor's right, title and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the "Patent and Trademark Collateral"), whether presently existing or hereafter arising or acquired which, includes the Grantor's rights to:

- (i) each United States patent and patent application, including each Patent and Patent Application referred to on Schedule A hereto;
- (ii) each United States trademark, trademark registration and trademark application, and all of the goodwill of the business connected with the use of, and symbolized by, each trademark, trademark registration and trademark application, including each Trademark, Trademark Registration and Trademark Application referred to in Schedule B hereto; and
- (iii) all products and proceeds of the foregoing, including any claim by the Grantor against third parties for past, present or future infringement of any Patent, or past, present or future infringement or dilution of any Trademark or Trademark registration, including any Patent or Trademark listed on Schedule A or B hereto, or for injury to the goodwill associated with any Trademark or Trademark Registration.

THIS GRANT is granted in conjunction with the security interests granted to the Grantee pursuant to the Security Agreement among the Grantor, the Grantee and certain other parties dated as of June 2, 2014, as amended, modified or supplemented from time to time (the "Security Agreement"). The rights and remedies of the Grantee with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Agreement are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

15 U.S.C. § 1051(d), respectively, or, if filed, has not been deemed in conformance with 15 U.S.C. § 1051(a) or (c), if the grant of a security interest in such intent-to-use Trademark is in violation of 15 U.S.C. § 1060 or would otherwise impair the validity or enforceability, or result in the voiding, of such intent-to-use Trademark application or any registration that may issue therefrom; provided, however, that upon the filing with, and examination and acceptance by, the United States Patent and Trademark Office of a "Statement of Use" or "Amendment to Allege Use", such intent-to-use Trademark application shall automatically become part of the Patent and Trademark Collateral and subject to the security interest granted herein.

This Grant of Security Interest in United States Patents and Trademarks may be authenticated by the parties hereto in any number of counterparts, each of which shall collectively and separately constitute one agreement.
