Whereas, CD PROJEKT S.A, a Polish joint stock company, having a place of business at ul. Jagiellońska 74, 03-301 Warszawa, Poland, ("ASSIGNOR") has adopted, owned and used the trademark **THE WITCHER**, registered in the U.S. Patent and Trademark Office, as Registration Number 3,276,016 on August 7, 2007, and filed with the U.S. Patent and Trademark Office, as Application No. 85/793,040 on December 3, 2012; and

Whereas, CD PROJEKT Brands S.A., a Polish joint stock company, with its principal place of business at ul. Jagiellońska 74, 03-301, Warszawa, Poland, ("ASSIGNEE") is desirous of acquiring said mark and the registration and the application thereof;

Whereas, pursuant to and as set forth in a certain Agreement on Sale of Trademark Protection Right between ASSIGNOR and ASSIGNEE dated October 1, 2014, ASSIGNOR assigns the trademark **THE WITCHER**, the registration thereof, the application thereof, and the goodwill associated therewith to ASSIGNEE;

Now, therefore, for good and valuable consideration, receipt of which is hereby acknowledged, ASSIGNOR agrees that ASSIGNOR hereby assigned unto ASSIGNEE nunc pro tunc effective as of October 1, 2014, all right, title and interest in and to the trademark **THE WITCHER** throughout the world, the above-identified registration thereof and the above-identified application thereof, together with all derivations thereof and including all goodwill associated therewith, whether based on common law or the laws of the various states, and the right (but not the obligation) to assert such trademark and other assigned rights to collect for all past, present and future infringements, and claims for damages and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits and all rights corresponding thereto throughout the world by reason of any past and future acts of infringement that have occurred or may occur.
