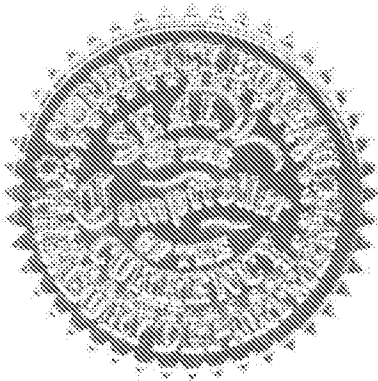
CERTIFICATION OF NATIONAL BANK TITLE CHANGE
