ASSIGNMENT AND ASSUMPTION

Reference is hereby made to the First Lien Credit Agreement dated as of June 7, 2013 (as amended, supplemented, amended and restated or otherwise modified from time to time prior to the date hereof, the "Credit Agreement") among the Borrower, Credit Suisse AG, a Cayman Islands branch of a bank organized and existing under the laws of Switzerland, with an office at Eleven Madison Avenue, New York, New York 10010, as collateral agent (the "Current Collateral Agent") and administrative agent, the lending institutions from time to time parties thereto and the other agents and entities party thereto and the First Lien Pledge and Security Agreement, dated as of June 7, 2013, among the Borrower, the Loan Parties (as defined in the Credit Agreement) party thereto (the Borrower and such Loan Parties, collectively, the "Reaffirming Parties") and the Current Collateral Agent for the benefit of the Secured Parties (as amended, supplemented, amended and restated or otherwise modified from time to time prior to the date hereof, the "Security Agreement"). Capitalized terms used and not otherwise defined herein shall have the meanings assigned to them in the Amended and Restated Credit Agreement (as defined below).

WHEREAS, pursuant to the Credit Agreement, the Current Collateral Agent has been granted security interests in the Patent Collateral (as defined in the Patent Security Agreement) and Trademark Collateral (as defined in the Trademark Security Agreement) under (i) the First Lien Patent Security Agreement dated as of June 7, 2013 (the "Patent Security Agreement") and recorded in the U.S. Patent and Trademark Office on July 19, 2013 at Reel/Frame Nos. 30831/0549, 30833/0660, 30831/0606, 30833/0700, 30833/0727 and (ii) the First Lien Trademark Security Agreement dated June 7, 2013 (the "Trademark Security Agreement") and recorded in the U.S. Patent and Trademark Office on July 18, 2013 at Reel/Frame Nos. 5073/0804, 5073/0300, 5073/0817, 5073/0834, respectively.

WHEREAS, pursuant to Amendment No. 1, dated as of October 31, 2013, the Credit Agreement is being amended and restated in the form of the Amended and Restated Credit Agreement on the Amendment No. 1 Effective Date and the Security Agreement is amended and restated in the form of the Amended and Restated Security Agreement.

WHEREAS, pursuant to the Resignation and Appointment Agreement, dated as of October 31, 2013, Barclays Bank PLC, a corporation organized in the United Kingdom, with an office at 745 Seventh Avenue, 26<sup>th</sup> Floor, New York, New York 10019 (the "Successor Collateral Agent") has succeeded to all of the Current Collateral Agent's rights and obligations as the "Collateral Agent," and the parties are executing this Assignment and Assumption to further evidence such succession with respect to the Patent Collateral and Trademark Collateral identified in the Patent Security Agreement and the Trademark Security Agreement.

Accordingly, effective as of October 31, 2013, the Current Collateral Agent hereby irrevocably assigns, without recourse, to the Successor Collateral Agent, and the Successor Collateral Agent hereby assumes, all of the Current Collateral Agent's rights and obligations as the "Collateral Agent" in, to and under the Patent Security Agreement and the Trademark Security Agreement, including,

but not limited to, the security interest granted in the Patent Collateral and the Trademark Collateral set forth on Schedule I hereto.

From and after the date hereof, (a) the Successor Collateral Agent shall be a party to the Patent Security Agreement and the Trademark Security Agreement and assume the rights and obligations of the Current Collateral Agent (as defined in the Patent Security Agreement and the Trademark Security Agreement) thereunder and shall be bound by the provisions thereof, and (b) the Current Collateral Agent shall relinquish its rights and be released from its obligations under the Patent Security Agreement and the Trademark Security Agreements.

This Assignment and Assumption shall be governed by and construed in accordance with the laws of the State of New York.


