WHEREAS, substantially all of the assets, rights and properties of Assignor (including the Intellectual Property as defined and described herein, the "Collateral") were subject to a first-priority, perfected security interest and lien granted to Assignor's senior secured lender (the "Secured Party"); and

WHEREAS, on July 2, 2014, the Secured Party conducted a foreclosure sale under Article 9 of the Illinois Commercial Code, 810 ILCS 5/9-101 et seq., with respect to the Collateral (the "UCC Sale"); and

WHEREAS, Assignee was the successful bidder for and purchaser of the Collateral at the UCC Sale; and

NOW THEREFORE, Assignor, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, DOES HEREBY irrevocably and unconditionally sell, convey, assign, transfer, and deliver to Assignee, its successors and assigns, all right, title and interest in and to the Intellectual Property, together with the goodwill of the business connected with such Intellectual Property and any right to recover for past infringement of Intellectual Property, TO HAVE AND TO HOLD without reservation and with all of the rights and appurtenances thereto belonging unto Assignee, for itself, its successors and assigns for their own use and behalf forever; and Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks to transfer all patents, trademarks and service marks included in the Intellectual Property to Assignee.

For good and valuable consideration, the sufficiency of which is hereby acknowledged, Assignor covenants that Assignor will do, execute and deliver, or will cause to be done, executed and delivered, all such further reasonable acts, transfers, assignments and conveyances, powers of attorney and assurances, for the better assuring, conveying and confirming unto Assignee of

Assignor's the entire right, title and interest in and to the Intellectual Property as Assignee may reasonably require.

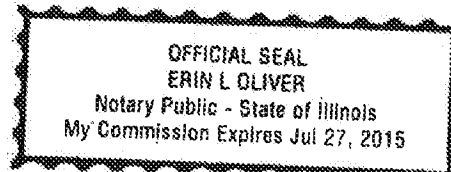
